2. COLLECTION TIMES

Granite Hill offers a late check out of 12.00pm. After 12 noon you are charged for that day.

3. I would like my dog to be housed with a compatible dog (although fed separately).
 (a) I request separate, individual housing. I understand this incurs a higher daily rate as listed daily rates are based on twin share accommodation.
 (b) I agree for my small dog(s) to be socialised with other small compatible dogs under supervision.

4. I understand that there is a one off fee \$20-\$55 per guest if boarding for 3 days or more. This covers shampoo/conditioning, brushing and health checks.

(a) A 15% surcharge applies to, Saturdays, Sundays, Public holidays and Peak periods. There is a \$10 departure fee on the morning of leaving before 12.00 (this covers feeding, exercise and cleaning)
 (b) Bank fees apply to all card payments.

5. I agree that provided proper and reasonable care be taken, Granite Hill and/or the Proprietors shall not be responsible in any way whatsoever for any loss or damage during the period of board. For the purposes of this contract, the person leaving the pet shall be deemed to be the agent of the owner.

6. Canine Cough: I understand this is the equivalent of a human cold or flu virus. Whilst Granite Hill ensures a spotless environment and only accepts fully vaccinated guests, vaccination can only **reduce symptoms**, they do not prevent my dog contracting canine cough as it is an airborne virus that is brought into the facility by dogs and floats around the Melbourne region during certain times of the year.

7. Older dogs: I understand that there can be higher risks associated with boarding a dog over 10 years of age.

8. I approve for photos/videos of my dog(s) to be posted to social media via Facebook/Instagram.

9. I acknowledge that my dog(s) worming and C5 is up to date.

Please note: We cannot accept guests who have been vaccinated with an intranasal or oral live vaccine within 14 days of admission.

10. In the event of my dog(s) requiring veterinary attention, Granite Hill shall use a local veterinarian in the first instance, and the owner of the boarder shall be liable for the costs of such attention.

10 (a). I authorise for my credit card details to be used should my dog(s) require treatment at a 24 hour emergency clinic or other veterinary clinic as required.
